Once again, we are experiencing some difficulty with Dunedin Railways again who, for reasons best known to themselves, are targeting six platform staff

- our lowest paid members - and an LE for a reduction in their customary hours over the winter. The cost saving is minimal at a time when the company's interim report is very bullish and four of the six members are women, including the LE!

We are exploring our legal options to challenge this and a petition is circulating via social media. We are also encouraging members and their families and friends to write to the CEO of Dunedin Railways

asking that the Company reconsider. Please back our members at Dunedin Railways and get active in their support.

### DFB 7267 RED CARDED

A trained RMTU H&S Representative is a fearless champion for workplace safety. This is borne out by a recent email from one of our reps that we received.

"This email is to notify KiwiRail that as a trained health and safety representative I believe there is a serious risk of harm to on-board staff and passengers associated with operating loco DFB 7267. I am directing workers to red card (cease operating) the DFB 7267 on the grounds of safety.

There have been incidences recently including two incidents yesterday when the loco suddenly lost power, dumped air and went into an emergency brake application. This caused the loco to come to an abrupt stop. This occurred twice both within the Rimutaka tunnel and again at Woodside. Additionally train control not automatically alerted following the emergency brake application inside Rimutaka tunnel. I consider this risk to passengers and on board staff is so serious (particularly if the loco stops inside Rimutaka tunnel or on a bridge) that DFB 7267 should be out of service until the faults are adequately addressed. Currently LE's have lost trust and confidence in DFB 7267 to function safelv".

### EMPLOYER FACEBOOK PAGES, CAVEAT EMPTOR!

Facebook posts workers have had serious implications for their employment. Most employers have IT policies that can mean what you post can be held against you. We now see employers starting Facebook and pages inviting workers to join. Clearly that would not be the place to have a rant also by liking, friending or joining these pages, it does open up individuals Facebook pages to employers. You pages may have old or

current content that you may not want your boss snooping around at.

One option is to have a Facebook profile/log on for specific purposes, like a work FB profile and a private FB profile and never the twain shall meet.





# RAIL AND MARITIME WORKERS MARK WORKERS MEMORIAL DAY TOMORROW IN EVENTS ACROSS THE COUNTRY

The Rail and Maritime Transport Union (RMTU) is marking Workers' Memorial Day on April 28 at events across the country, including unveiling a new memorial in Kawerau dedicated to workers who never made it home.

"Workers' Memorial Day is where New Zealanders up and down the country pay tribute to those who lost their life on the job," said RMTU General Secretary Wayne Butson.

Every year 50-60 people are killed in a work incident and 600-900 more die early deaths as a result of work-related ill-health.

"For our members today takes on special significance. We've lost a lot of mates over the last couple years, from both accidents on the job and from early deaths after exposure to chemicals like asbestos. Today is when we stop to acknowledge their lives and the families they left behind."

"The message on Workers' Memorial Day is especially important this year. Over the last fortnight 7 people lost their lives on the job," said Butson.

Events are taking place up and down the country tomorrow with Wayne Butson helping unveil a new workers' memorial in Kawerau alongside local mayor Malcolm Campbell at noon and members of the Pike River families attending RMTU events on the West Coast at the Union Hotel and in Christchurch at the memorial gardens on Gasson Street.

"No one should clock on at work and never come home. Every working person is entitled to safety at work," said Butson

# LYTTELTON PORT SUCCESSFUL DELEGATE SEMINAR

We had an excellent turnout at our delegate seminar held on 6th April. The day was devoted to preparation for this year's bargaining round with commences in early July prior to expiry of the RMTU-LPC Waterfront Collective Agreement on 7th September.

Representatives from all the major departments covered by the collective agreement attended and we covered a range of possible approaches to bargaining: including positional, strategic and interest based bargaining styles. We also learned some analytical techniques to apply in handling negotiations. There was some lively debate and stimulating debate and the delegates reached a solid consensus on the following:

- There can be no reductions in terms and conditions as a result of this bargaining round
- Remits for bargaining will be called for in early May. The remits will be prioritised by the delegate team on the basis of whether they are deeply

and widely felt how i.e. many people back a remit and are they prepared to take action to support it. We will hold a full branch meeting in June to endorse the remits that delegates propose

forming the log of claims.

 The RMTU will be in a position to commence bargaining at soon as we have initiated in early July.

We are preparing a packed programme that includes:

### **TUNNELS UPDATE**

KiwiRail has notified Worksafe that they are complying with the Worksafe Improvement notice to provide self contained self rescuers (SCSR's) to all tunnels greater than 1000metres. This improvement notice is separate from the notice to introduce CABA into Otira Tunnel.

KiwiRail has procured sufficient Draeger SCSR for provision to all KR staff and divisions of the KR business such as Operations, Network Services, and KR Passenger etc. that operate within tunnels on the KR network, including tunnels greater than 1,000m in length.

KR has completed the SCSR training for all Network Services staff that operates in tunnels greater than 1,000m in length.

KR will have completed the SCSR training for all Operations staff that operate in tunnels greater than 1,000m in length by 11 May 2017.

Transdev have not provided SCSR's to LE's or on-board staff at this stage. This will be an item of discussion at the next Lower North Island focus group meeting being held on the 9th of May.
